ABOUT ASU

Mission Statement: Angelo State University, a member of the Texas Tech University System (TTUS), delivers undergraduate and graduate programs in the liberal arts, sciences and professional disciplines. TTUS is a state university system in Texas consisting of four separate universities, of which two are academic universities: **Angelo State University** and **Texas Tech University**, and two are medical universities: **Texas Tech University Health Sciences Center**, and **Texas Tech University Health Sciences Center at El Paso**.

ELLACY GLOBAL EDUCATION SCHOLARSHIP PROGRAMS

- ✓ **Ellacy Global Education (EGE) Scholarship** - Angelo State University has special scholarship programs for *Ellacy Global Education* students. Through an unique partnership with ASU, all EGE students will receive special EGE Scholarship (worth approximately \$12,525 USD) that will reduce tuition cost from approximately \$20,751 down to \$8,216. The scholarship works by ASU paying to reduce student's tuition cost from International Student tuition rate down to Texas Resident tuition rate. Estimates are based on 30 credit hours for a full academic year. The scholarship is automatically renewed to EGE students until their graduation, provided the student maintain at least a 2.0 GPA at the end of each academic year.

In addition, EGE students are eligible for Carr scholarships for new freshmen students, Carr Graduate scholarships for new graduate students, Carr Transfer scholarships for students already in the U.S., Carr Earn-In scholarships for students already at ASU, Carr Summer

Ellacy Global Education – ASU Scholarships

Scholarships, and summer housing assistance. Below are scholarships available to EGE students.

✓ **Ellacy Global Education (EGE) Scholarships: (\$52,140 USD + additional scholarships)**

1. **EGE In-State Tuition Scholarship** - Approx \$12,525 USD per year for 4 years, or approx. \$52,140 in total. Scholarship to reduce International student tuition rate to In-state Tuition.
2. **Carr Summer Scholarship**: \$500 - \$1,000 in scholarships per summer.
3. **ASU Summer Housing** – approx. \$2,000 in value. Free summer housing during Summer I & II terms

CARR SCHOLARSHIPS (available for EGE students)

Carr Scholarships for Freshmen (\$4,000 to \$72,000 over 4 years)

1. Carr Distinguished Scholar: \$15,000 per year + \$3,000 for Honors Program
2. Carr Excellence Scholar: \$6,000 per year + \$3,000 for Honors Program
3. Carr Fellow Scholar: \$4,000 per year + \$3,000 for Honors Program
4. Carr Academic Scholar: \$3,000 per year
5. Carr Gold Scholar: \$2,000 per year
6. Carr Blue Scholar: \$1,000 per year
7. Carr Honors Program Students: \$3,000 in additional to other scholarships
8. **TERMS & CONDITIONS**
 - a. Students must be enrolled full time (at least 12 semester credit hours)
 - b. 2.5 institutional GPA at the end of the first academic year
 - c. 3.0 institutional GPA at the end of each subsequent academic year
 - d. Complete 30 credits each academic year (fall/spring)
 - e. Scholarship based on GPA and SAT scores



Carr Scholarships for Current ASU Undergraduates (\$3,000 to \$6,000)

1. Carr Earn-In Fellow Scholar: \$2,000 per year
2. Carr Earn-In Academic Scholar: \$1,500 per year
3. Carr Earn-In Gold Scholar: \$1,000 per year
4. **TERMS & CONDITIONS**
 - a. Students must be enrolled full time (at least 12 semester credit hours)
 - b. 3.0 institutional GPA at the end of each academic year
 - c. Complete 30 credits each academic year (fall/spring)

Carr Scholarships for US Transfer Students (\$5,000 to \$12,000)

1. Carr Presidential Scholar: \$3,000 per year (\$6k Max) + \$1,000 for Phi Theta Kappa
2. Carr Fellow Scholar: \$2,000 per year (\$4K Max) + \$1,000 for Phi Theta Kappa
3. Carr Gold Scholar: \$1,500 per year (\$4.5K Max) + \$1,000 for Phi Theta Kappa
4. Carr Blue Scholar: \$1,000 per year (\$3K Max)
5. Phi Theta Kappa Scholarship - \$1,000 in additional to other scholarships
6. **TERMS & CONDITIONS**
 - a. Transfer students must transfer from a US school to ASU to qualify
 - b. Students must be enrolled full time (at least 12 semester credit hours)
 - c. 3.0 institutional GPA at the end of each academic year

Ellacy Global Education – ASU Scholarships

Carr Graduate Scholarships (\$3,000 to \$5,000)

1. Carr Graduate Fellow Scholar: up to \$2,500 per year
2. Carr Graduate Academic Scholar: up to \$2,000 per year
3. Carr Graduate Blue and Gold Scholar: up to \$1,500 per year
4. TERMS & CONDITIONS
 - a. Students must be enrolled full time (at least 9 semester credit hours)
 - b. 3.5 institutional GPA at the end of each academic year
 - c. Complete 12 credits each academic year (fall/spring)

Summer Carr Scholarship (\$500 per Summer)

1. Summer Carr Scholarship: up to \$1,000 per Summer (I & II)
2. Student in good standing with the Carr Satisfactory Academic Progress requirements.
3. TERMS & CONDITIONS
 - a. NEW Undergraduate must complete 30 semester credit hours
 - b. NEW Undergraduate maintain 3.0 GPA at the end of each academic year
 - c. NEW Graduate must complete 18 semester credit hours (prorated)
 - d. NEW Graduate maintain 3.5 GPA at the end of each academic year
 - e. TRANSFER Undergraduate student transfer GPA 3.0
 - f. TRANSFER Undergraduate ASU Spring semester GPA 3.0
 - g. TRANSFER Graduate must complete 9 semester credit hours (prorated)
 - h. TRANSFER Graduate ASU Spring semester GPA 3.5

**Angelo State University awards approximately 975 new undergraduate Carr Scholarships and 150 new Carr Graduate Scholarships each year. Carr Scholarships are renewable per the eligibility guidelines. New Carr Scholarships for undergraduate and graduate students are available for students entering in a fall or spring semester. ASU awards more than \$2 million in Carr Scholarship funds to new undergraduates and more than \$380,000 in Carr Graduate Scholarship funds to new graduate students. The university is authorized to award scholarships until the appropriated funds are reached.
